### **BYLAW 2-2016**

# A BYLAW FOR THE PURPOSE TO DESIGNATE INDUSTRIAL SUBDIVISON, ROAD NAME AND STREET ADDRESSES

Whereas the Council Of the Rural Municipality of Dufferin No. 190 in the Province of Saskatchewan wishes to enact a bylaw to designate an industrial subdivision and assignment address numbers to individual parcels and to designate a road name within the Rural Municipality;

**Now therefore** the Council of the Rural Municipality of Dufferin No. 190 in the Province of Saskatchewan, in acts enacts as follows:

#### 1. Short Title

This Bylaw may be referred to as the K+S Subdivision Bylaw.

#### 2. Purpose and Intent

This bylaw is intended to:

- (a) identify an area to be described as the "K+S Industrial Subdivision";
- (b) identify a road in the said subdivision to be named "Legacy Way";
- (c) assign addresses to certain parcels on the said road.

#### 3. Subdivision

The land legally described as: all of Section 34 and all of Section 35, both in Township 19, Range 25, West of the 2nd Meridian, Province of Saskatchewan, and the Northwest quarter of Section 26 and the Northeast quarter of Section 27, both in Township 19, Range 25, West of the 2nd Meridian, pProvince of Saskatchewan is designated as the "K+S Industrial Subdivision."

# 4. Road Name

The road traveling in a north-selfsouth-direction between Legal Subdivisions 9 and 16, NE 34-19-25-W2M and NW 35-19-25-W2M and then continuing along the western edge of Legal Subdivisions 4 and 5 in NW 35-19-25-W2M and then proximate to the western edge of SW 35-19-W2M in the said subdivision shall be known as "K+S Way".

#### 5. Road Addresses

The parcel of land legally described as Legal Subdivision 5, SW 35-19-25-W2M (Main Security Gate) shall be designated as "100 K+S Way" and the parcel of land legally described as Legal Subdivisions 4 and 5, SW 35-19-25-W2M shall be designated as "101 K+S Way (Administration Building)".

## 6. Coming Into Force

This bylaw shall come into force and effect on the date of its final adoption.

READ A FIRST TIME this 17<sup>TH</sup> day of February, 2016.

READ A SECOND TIME this 17<sup>TH</sup> day of February, 2016.

READ A THIRD TIME UPON THE UNANIMOUS CONSENT OF THE COUNCIL this  $17^{\rm TH}$  day of February, 2016.




