A Bylaw to Authorize the Expropriation of Land from:

- 4) *SE ¼ 5 Twp 20 Rge 23 W2*
- 5) *NW ¼ Sec 35 Twp 19 Rge 23 W2*
- 6) *SE ¼ Sec 6 Twp 20 Rge 23 W2*
- 7) *NW ¼ Sec 31 Twp 19 Rge 23 W2*

The Council of the R.M. of Dufferin #190 in the Province of Saskatchewan enacts as follows:

1. The Council of the R.M. of Dufferin #190 deems it necessary to acquire title to a portion of the following lands noted as:


