

**RURAL MUNICIPALITY OF DUFFERIN NO. 190**

**BYLAW NO. 01-2024**

**TO REPEAL OUTDATED OR EXPIRED BYLAWS AND AGREEMENTS**

The Council of the Rural Municipality of Dufferin No. 190, in the Province of Saskatchewan, enacts as follows:

**1.0 SHORT TITLE**

1.1 This bylaw shall be referred to as the “Repealing Bylaw”.

**2.0 REPEALING**


2.1 The following bylaws are hereby repealed:


- a) Bylaw 01-1988, to provide for a recreation board;
- b) Bylaw 02-1997, to provide for the sale or exchange of walkway in North Shore Estates;
- c) Bylaw 05-1998, to provide for the closing and leasing of certain roads;
- d) Bylaw 06-1998, to extend the hours of voting in elections;
- e) Bylaw 04-1999, to provide for the closing and leasing of certain roads;
- f) Bylaw 01-2000, to provide for the closing and leasing of certain roads;
- g) Bylaw 02-2000, to provide for the closing and leasing of certain roads;
- h) Bylaw 06-2000, to provide for the closing and leasing of certain roads;
- i) Bylaw 02-2002, to provide for the closing and leasing of certain roads;
- j) Bylaw 03-2002, to provide for the closing and leasing of certain roads;
- k) Bylaw 09-2002, to regulate the speed of vehicles in North Shore Estates;
- l) Bylaw 09-2006, to set the fire call out fees charged to outside municipalities;
- m) Bylaw 12-2006, to set the fire call out fees charged to ratepayers of the Village of Bethune and RM of Dufferin No. 190;
- n) Bylaw 02-2008, to provide for the numbering of houses and other buildings in North Shore Estates;
- o) Bylaw 15-2008, to provide for the closing and leasing of a municipal road or street;
- p) Bylaw 06-2012, to close and lease an undeveloped road allowance;
- q) Bylaw 07-2012, to close and lease an undeveloped road allowance;
- r) Bylaw 08-2012, to close and lease an undeveloped road allowance;
- s) Bylaw 05-2014, to close and lease an undeveloped road allowance;
- t) Bylaw 07-2014, to repeal outdated or expired bylaws and agreements;
- u) Bylaw 13-2015, to close and lease an undeveloped road allowance;
- v) Bylaw 14-2015, to close and lease an undeveloped road allowance;
- w) Bylaw 15-2015, to close and lease an undeveloped road allowance;
- x) Bylaw 16-2015, to close and lease an undeveloped road allowance;
- y) Bylaw 17-2015, to close and lease an undeveloped road allowance;
- z) Bylaw 02-2017, to close and lease an undeveloped road allowance;
- aa) Bylaw 15-2006, respecting animals running at large;

- bb) Bylaw 01-2018, to regulate the speed of motor vehicles on TWP Road 200; and
- cc) Bylaw 04-2016, usage requirements for municipal reserve property at Highwood Beach.

**3.0 This bylaw shall come into force and take effect on final passing thereof.**


