Request to borrow by debenture 16. Bennett That application be made to the Local Government Committee for permission to borrow by way of debenture, the sum of \$325,000, in 2025 repayable over a period of three years, for the purpose of purchasing a grader. CARRIED

Debenture to be repayable so that the principal and interest are combined and made payable in equal annual instalments during the term of securities interest at the rate of ~3.13% per centum, per annum, payable at least annually.

Hwy 2 Passing Lane Endorsement 17. Fishley That the Council endorse the passing lane positions on Highway 2, as attached hereto. CARRIED

CCBF IIP 18. Riche That the Council approves the Infrastructure Investment Plan proposal regarding the paving of Legacy Road as presented by the Administrator as part of the requirements of the Canada Community Building Fund Agreement and that the same be submitted to the Ministry of Government Relations accordingly. 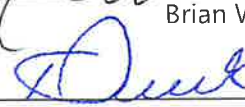
